JERKY DIRECT TERMS & CONDITIONS

The individual/entity (herein: "Distributor") agrees to the terms set below between the Company (herein: "Jerky Direct") and Distributor.

1. The Distributor is, and at all times shall remain, an independent contractor and is not, and shall not be, construed to be a partner, joint venture, employee, agent, representative, or participant of or with the Company for any purpose whatsoever. Distributor agrees to be responsible for their own expenses, license, local, state, and federal taxes, except whereby collection and payment of sales taxes are expressly arranged by Jerky Direct.
2. Jerky Direct marketing and compensation program with its Policies and Procedures, Rules and Regulations, and Advertising Guidelines, which may be amended from time to time, is hereby incorporated into, and made a part of this Agreement.
3. Distributor will not misrepresent Jerky Direct in any manner and will make no statements, claims, or warranties respecting Jerky Direct which are not contained in Jerky Direct written material. Distributor agrees to perform all of its obligations under this Agreement in a manner consistent with all applicable laws and Regulations and with the principles of good conduct and business ethics, in order to protect and enhance the name of the Company, the reputation of the product, and the goodwill attached to any trade names or any trademarks in use or hereafter adopted or used by the Company.
4. Distributor understands and agrees that the products are not pharmaceutical and are never offered or intended for medical treatment of any diseases or disorders. Jerky Direct and/or any of its Distributors are prohibited from participating in any diagnosis, prognosis, evaluation, treatment, description, or management of any diseases or physical or mental disorder. Every Distributor understands and agrees that they will not make any medical claims relating to any Jerky Direct product. The Distributor understands by making any such claim, it could have the effect of the product being determined as a medical product and subject to substantial Rules and Regulations under the Food and Drug Administration. A violation of this Rule will result in immediate termination of any relationship with Jerky Direct.
5. Distributor understands that there are no guarantees of earnings in the Jerky Direct marketing program and there are not exclusive territories within the program. Distributor will receive bonuses, overrides, and royalties from sponsored Distributors only to the extent that those Distributors and the Distributors they sponsor sell the product or purchase it for their own use.
6. Distributor also understands there are no inventory requirements of the products marketed by Jerky Direct and that the Distributor may terminate the Agreement at any time by written notice.
7. Distributor understands and agrees that a violation of any of the terms of the Agreement, including the Policies and Procedures of Jerky Direct may result in the termination of Distributor's authorization as a Jerky Direct Distributor.
8. This Agreement shall be governed by the state laws of Idaho, and all claims, disputes, or other matters between the parties shall be brought to state or federal court in Bonneville County, Idaho, unless approved in writing by Jerky Direct.
9. By entering the Social Security or Federal ID Number, Distributor is certifying that the number shown on this form is the Distributor's correct taxpayer identification number.
10. The effective date of this Distributor Agreement shall be the date it is received at Jerky Direct corporate office.
11. Distributor agrees not to participate with or use an unauthorized website for internet sales of Jerky Direct Products. If found doing so, Jerky Direct reserves the right to terminate the Distributors relationship with Jerky Direct.
12. Distributor understands that violation of any Rule or Regulation hereunder or otherwise violation of any federal, state, or local laws that would in any way affect Jerky Direct, shall immediately terminate this Agreement. If Jerky Direct does terminate this Agreement, that subject to any law, the Distributor agrees not to make a claim against the Company. If the Distributor does pursue a claim against the Company and does not prevail, he/she shall reimburse the Company for any cost of defense, including reasonable attorney's fees.
